

Advanced Highway Safety Manual Workshop

This is a 2-day training course that will include theoretical principles and application of the *Highway Safety Manual* (HSM) methodologies tailored to FDOT design engineering practices and methods. The course will detail the steps involved in applying HSM methodologies and illustrate the benefits HSM methodologies may provide. Sample HSM applications in a workshop setting will be incorporated throughout the training sessions. This course has 16 PDHs.

Flexible Pavement Design
