President's Message

As many of you know, I am the Treasure Coast Chapter representative on the Rivers Coalition. In recent weeks, there has been numerous stories in the newspaper and television regarding the fresh water releases to the St. Lucie River. To quote Mark Perry, Executive Director of the Florida Oceanographic Society, "The St. Lucie River and the Indian River Lagoon are as black as expresso, with that same oily sheen and foam on top. The ocean is brown as coffee from the St. Lucie Inlet as far north as Ft. Pierce and south to Jupiter."

This should be a major concern to all of us as engineers, but also to anyone who enjoys watersports. There were numerous commercial fishermen that attended our last Coalition meeting to express that the releases are destroying their livelihood. Has anyone else noticed that the fish just aren't there?!

Martin County Commission Chair Michael DiTerlizzi was present at our meeting, and stated that he has already began dialogue with County Attorney Stephen Fry to file suit to stop the fresh water releases.

Representative Joe Negron was also in attendance. Rep. Negron stated that he believes we need to work through our legislature to address the releases. He is a member of the Appropriations Committee, which approves the South Florida Water Management District's funding. He suggesting cutting funding that goes toward releases.

The Rivers Coalition Board voted to establish a Legal Task Force to work with Martin County toward filing a law suit to stop the releases. This task force has met twice in the last two weeks.

The issue at hand is the South Florida Water Management District believes there is not choice but to discharge water. Lake Okeechobee is too high, and according to the District, the canals to the south do not have the capacity to accept more water.

All NSPE members are eligible and encouraged to get involved in the Engineer Ambassador program. Members of Congress pay attention and respond to what they hear from their constituents. Engineer Ambassadors can take advantage of their unique position as technically trained constituents to influence public policy by offering Members hands-on engineering expertise.

HOW IT WORKS:

NSPE uses the Legislative Action Center located on the NSPE Web site to notify Engineer Ambassadors of legislative issues. The LAC contains legislative action alerts, which are linked to letters that can be sent to individual members of Congress at the click of a button. There is also information on the key bills of importance to NSPE and engineers across the country. When critical legislative issues arise, Engineer Ambassadors are notified by an e-mail alert. In a coordinated effort, Ambassadors contact their Representatives and/or Senators by e-mail, telephone, fax, or a personal visit to urge them to take particular positions on issues. This grassroots coordinated effort can have a big impact on getting Congress to support issues vital to the livelihood of the engineering profession.



South Florida Stormwater Best Management Practices User's Group Meeting:

Title of Presentation: Stormwater Filtration and Nutrient Removal Systems

Presenter Tom Happel - Suntree Technologies, Inc.

The presentation will cover stormwater filtration, particulate settling, and nutrient removal technologies. The following specific technologies to be presented in extensive detail:

A Grate Inlet Skimmer Box and the Curb inlet Basket are durable inlet filters that are designed to be a part of the permanent infrastructure of the storm drain system. They can be easily retrofitted to existing inlets. They incorporate flow bypass systems to allow for adequate drainage functions.

The Nutrient Separating Baffle Box, often referred to as the Second Generation Baffle Box, is a large underground filtration system that installs in line with a storm drain pipe. This Nutrient Separating Baffle Box has been able to capture sediment, foliage, hydrocarbons, and other pollutants. The Nutrient Separating Baffle Box can be retrofitted to existing storm drain pipes & systems with minimal head loss, and it is designed to treat the entire flow.

The presentation will have immediate impact for municipal stormwater officials and consulting engineers facing the difficult problems associated with stormwater pollution issues, and we encourage all interested people to attend.
