We take this moment to salute all of our members because we have successfully passed the mantle across 3 decades of engineering in Martin, St Lucie, Okeechobee and Highlands County.

Since 1987, our members have organized and fulfilled the duties of our Society for the greater benefit of the engineering profession and engineering education. For 30 years we have been successful at recruiting new members, maintaining the Chapter Board and volunteering our time and donating money to see that the future of engineering in our area continues to thrive and be a highly sought after career. Many thanks go out to our founding members, many who are still actively participating and attending events. We are also grateful for all of our members who have been faithful in their memberships and sponsorships and choose to support this Chapter financially.

It was in August of 1987 that Michael T. Hermesmeyer and Richard T. Creech traveled to FES Headquarters in Tallahassee with a signed petition to establish the Treasure Coast Chapter. There was about 30 original members who signed the petition. Our Chapter quickly became involved at the State level defending legislation to protect our environment, agriculture, and engineering law. Locally, we created our first fund raising and scholarship event: The FES Annual Golf Tournament.

As the years rolled by our Chapter grew towards 100 members. We established our annual events such as:




Figure 2: Annual Membership Growth Since Inception 1987-2017




Figure 4: 2017 Demographic Map of the Treasure Coast Region 5



# **Coming February 2018 Engineers Week**



### **NSPE Code of Ethics**

Engineering is an important and learned profession. As members of this profession, engineers are expected to exhibit the highest standards of honesty and integrity. Engineering has a direct and vital impact on the quality of life for all people. Accordingly, the services provided by engineers require honesty, impartiality, fairness, and equity, and must be dedicated to the protection of the public health, safety, and welfare. Engineers must perform under a standard of professional behavior that requires adherence to the highest principles of ethical conduct.

### **Fundamental Canons**

Engineers, in the fulfillment of their professional duties, shall:

- 1. Hold paramount the safety, health, and welfare of the public.
- 2. Perform services only in areas of their competence.
- 3. Issue public statements only in an objective and truthful manner.
- 4. Act for each employer or client as faithful agents or trustees.
- 5. Avoid deceptive acts.
- 6. Conduct themselves honorably, responsibly, ethically, and law fully so as to enhance the honor, reputation, and usefulness of the profession.
